THE POLICY CIRCLE BRIEF LIBRARY NOW WITH OVER 65 CURATED RESOURCES, FRAMES KEY POLICY ISSUES, EXPLAINS THE ROLE OF GOVERNMENT AT EACH LEVEL, AND EMPHASIZES ENTREPRENEURIAL SOLUTIONS. THESE BRIEFS ARE A CRITICAL ENTRY POINT INTO THE ORGANIZATION'S WORK AND CONTINUE TO GROW IN REACH AND IMPACT, WITH OVER 265,000 VIEWS IN 2024, MARKING A 24% INCREASE FROM THE PREVIOUS YEAR AND SURPASSING 1 MILLION LIFETIME VIEWS.

THE CIVIC LEADERSHIP ENGAGEMENT ROADMAP (CLER) IS A DYNAMIC, SELF-PACED LEADERSHIP PROGRAM DESIGNED TO EQUIP WOMEN TO LEAD IN THEIR COMMUNITIES WHETHER THROUGH ELECTED OFFICE, BOARD AND COMMISSION APPOINTMENTS, OR GRASSROOTS EFFORTS. IN 2024, CLER SAW A 112% INCREASE IN APPLICATIONS, WITH 177 WOMEN COMPLETING THE PROGRAM. TO DATE, 588 WOMEN HAVE PARTICIPATED, GENERATING MORE THAN 1,100 DOCUMENTED STORIES OF IMPACT. THESE INCLUDE 42 BOARD AND COMMISSION APPOINTMENTS, 24 ELECTED OFFICIALS, AND DOZENS MORE WHO HAVE TAKEN ON LEADERSHIP ROLES, LAUNCHED ADVOCACY EFFORTS, OR RUN FOR PUBLIC OFFICE. THE PROGRAM ALSO EXPANDED THROUGH SPECIALIZED TRACKS FOR WOMEN ENTREPRENEURS AND MEMBERS OF THE MILITARY COMMUNITY, FURTHER DEEPENING TPC'S REACH.
